04. The trustees are bound to maintain and defend all such suits and to take such other steps as regard being had to the nature and amount or value of the trust property, may be reasonable requisite for the preservation of the trust property and the assertion or protection of the title thereto.

08. Board of Trustees:-



There shall be two bodies of the trust;

- (1) General Body shall consist, all the members, who seek its membership by applying and depositing basic membership fee of Rs.1100/=
- (2) **Executive Body:-** The executive body shall consist not less than 5 members. The founders shall be its basic members and shall hold office for life. The founders shall by consensus Co-opt to the executive body tow members. The members so co-opted shall be men of caliber, educated in their field of activity. - (e) He is authorized to make withdrawals from the bank, sign cheques, bills and documents on behalf of the trust, open accounts with the bank and operate upon the bank accounts alongwith treasurer.
- (f) He is authorized to make appointments, dismiss the employees so appointed or take disciplinary actions as warranted under rules.
- (g) All decisions shall be issued under his seal and signatures.

(2) General Secretary:-

He shall be elected from amongst the trustees /founders of the trust. He shall hold office for a period of three years. He is eligible to be re-elected for a second term.

Powers and functions of General Secretary:-

- (a) The General Secretary of the trust will act as co-ordinator between Executive body and General Body and also between various committees established for smooth functioning of the trust. He will act in close liason with other office bearers.
- (b) He will be responsible for monitoring of the affairs of trust especially in the absence of President/chairperson.

(3) Secretary:-

The Secretary shall be elected from amongst the Governing body called Executive body of the trust. He shall hold office for a period of three year. He is eligible to be re-elected for a second term.

Powers and functions of Secretary:-

- (a) He shall be responsible to convene the meetings of the trust and prepare the agenda for the same in consultation with the President and General secretary.

- (c) He shall submit all bills, cheques, and papers relating to accounts of the trust through secretary.

- (g) He fails to attend three consecutive meetings of the trust without any plausible cause or reason and without informing the management of the trust.
- (h) He takes part in any activity pre-judicial to the interest of the trust.

(14) Amendment of the constitution of the trust

The amendment of the constitution/Bye-Laws shall be passed by 2/3 majority present and voting.

(14) Dissolution of the trust:-

The trust can be dissolved by its Executive Committee by passing a resolution to that effect by a 2/3 majority present and voting.

In the event of the dissolution of the trust the assets, in kind or cash, shall be distributed among founders. The executive Committee can consider to pass such assets to any other trust with the consent of its members.

(16) Honorarium:-

All the official bearers/members of both the committees shall work on honorary basis.
